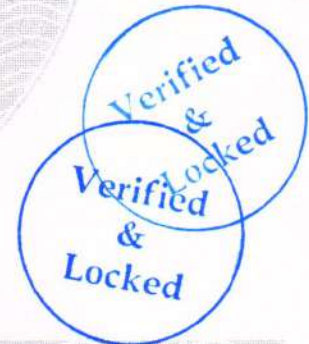

**THIS AMENDED TRUST DEED** is made on this, ..... day of ..... 2023 in continuation, to the Supplementary Trust Deed duly registered in Delhi with the Sub-Registrar VI A Delhi / New Delhi in the name of **BHARAT LOK SHIKSHA PARISHAD** vide its Registration No. 574 dated 08.07.2020 under Indian Trust Act, 1882.

Now this Amended Trust Deed made to the Supplementary/Principal Trust Deed pursuant to provisions contained therein & witnesses as follows: -

#### 1. NAME:

The name of the Trust shall be "**BHARAT LOK SHIKSHA PARISHAD**".  
(hereinafter called the Trust)

#### 2. OFFICE:

- **The Registered Office** of the Trust is at: A-131/3, Group Industrial Area, Wazirpur, New Delhi - 110052 or such other place within the NCT of Delhi as may from time to time, are decided by the Trust and
- **The Administrative Office** of the Trust is at: NS-15, FD Block, Pitampura, Delhi-110034 or such other place or places within the NCT of Delhi as may, from time to time, is decided by the Trust. The Branch Offices (Chapters) will be maintained as per the requirement anywhere in India.

#### 3. OBJECTS OF THE TRUST:

- i. To bring back and retain within the main social, economic and cultural stream, those who have been ignored and left behind, especially in forest, remote and under developed areas of India.
- ii. To highlight the problems and impart primary functional education to under-privileged people and strengthen the hands of agencies having similar objects who are working in underdeveloped remote and forest areas with dedication and vigour.
- iii. To initiate, undertake, carry on, engage in, promote, assist encourage, finance and conduct Scientific Research, Scientific Research & Development, Technical Research & Developments, Research in Social Science or Statistical Research, experiments, investigations, inquiries, studies, projects, analysis, examinations, surveys and test of all kinds including, but not limited to those related to economic, fiscal, commercial, financial, agricultural, medical, industrial, technical and scientific problems and matters in India.



- vii. To promote/ establish new scientific and biotechnology expertise for safeguarding the overall interests of Biotechnology as a science, profession, industry, trade or welfare and develop tools to assess the human health and environmental impacts of biotechnology products and substances.
- viii. To do all such acts and deeds which are necessary for establishment of informal education centers for the children in-need.
- ix. To establish and run or cause to be established and run schools, colleges, hostels and other educational institutions in order to promote education, including special education to Handicapped, Blind, Mentally Retarded Students, and employment enhancing vocation skills especially among children, women, elderly and the differently able and livelihood enhancement projects.
- x. To establish and run programs for advancement of yoga.
- xi. To establish and run or cause to establish and run such medical centers, hospitals, primary health centers or similar establishment by whatever name called for public health by way of care or counseling of terminally ill persons or persons with severe physical or mental disability; persons affected with HIV or AIDS; persons addicted to a dependence-forming substance such as narcotics drugs or alcohol; or public awareness of preventive health, family planning or prevention of HIV infection.
- xii. - xiii. To grant scholarships, stipends and financial help to deserving students to enable them pursue their studies and for purchasing books and educational equipment for promotion and encouragement of all type of education.
- xiv. To establish, maintain and contribute towards establishing and maintenance of hospitals, dispensaries, medical centers, maternity, family planning, libraries, reading rooms, boarding house, hostels and old age home.
- xv. To promote modern method of agriculture, horticulture, dairy, poultry, animal husbandry, social husbandry and such other cottage industry and to impart necessary knowledge/information. To conduct training programs for farmers in the field of agriculture and rural development.
- xvi. To establish Chapters, Branches and Youth & Mahila Vibhags (within the Branches/Chapters) for achieving the objects of the Trust.
- xvii. To raise funds by accepting any bequeath, gifts, donations, endowments, loan or subscriptions conditionally or unconditionally. To establish fund or endowment for the protection or attainment of the objects of the Trust and to invest the same.
- xviii. To acquire by, purchase, lease or otherwise properties, movable or immovable for the Trust for achieving aforesaid objectives, from time to time as may think fit.
- xix. To join, subscribe to, federate or affiliate with another association/institution/ Society/ Trust whose objects are in whole or in part similar to those of Bharat Lok Shiksha Parishad and simultaneously allow the same facilities and privileges to other bodies.
- xx. To implement faith developments programs by establishing and maintaining of Meditation Centers, Bhawans & to build up public opinion to eradicate social evils.
- xxi. To aid, organize, sponsor lectures, debates, discussions, meetings, seminars, programs and conferences for the advancement of human education and health services.
- xxii. To reduce child mortality and improving maternal health by providing good hospitals facilities and low cost medicines.
- xxiii. To establish and manage health care and other facilities and to run small educational centers, self-help group and other program for the development of the society.
- xxiv. - xxv. To nurture, plant, make grow the plantation trees of different species on the waste land in village, town and metropolitans and in schools, colleges, hospitals, road sides for preservation of environment including watershed, forests and wildlife and prevention of ecological imbalance/deforestation, to keep check and create pollution free environment.
- xxvi. To work self and with Central Government/ State Government/Bodies/ Private agencies for village development, research and development, innovation of Plants, mud, sand (Mitti), preventing of river destruction and other natural resources as per government schemes.
- xxvii. To promoting gender equality, empowering women, setting up homes and hostels for women and orphans setting up old age homes, day care centers and such other facilities for senior citizens and measures for reducing inequalities faced by socially and economically backward groups.
- xxviii. To co-operate with other Trusts, societies, institutions, and organizations in India for the pursuit of all or any of the above. For social activities, financial as well as material assistance will be provided to those mothers and children, who have difficulties in their health and education.
- xxix. To train, educate and empower the womenfolk and to spread awareness among the women in relation to education, health, human rights, family planning, child care, hygienic principles, sanitation etc. by virtue of which their position in the society will uplift.
- xxx. To provide medical care and education for the relief of poor and downtrodden people. Elderly care and anti-tobacco activities will be carried out throughout the nation. Training on indigenous medicine will be provided to housewives and they will be encouraged to practice within their family.
- xxxi. To eradicate hunger, poverty and malnutrition, promoting preventive health care and sanitation and making available safe drinking water.
- xxxii. To organize legal literacy camps to spread legal awareness and to provide legal assistance to needy person and to encourage and promote family welfare activities among needy people.
- xxxiii. To aid or undertake the schemes for the general literacy and adult education in the country.
- xxxiv. To promote, create awareness and conduct regular surveys, assessments, trainings, behaviour and attitudinal training programs in schools, colleges throughout the country.
- xxxv. To establish and run Hostels, Dharamshalas, Rest houses, Houses for poor, houses or other such charitable Institutions for the benefits of all classes at any suitable place or places.

- xxxvi. To maintain, contribute and to provide aid to any medical, education, social institutions or any charitable institutions with philanthropic purposes which may be in the general interest of the poor of all castes and creed and do all such acts and things with the objective of giving relief to the poor and downtrodden section of the society.
- xxxvii. To promote programs for family planning/family welfare and population control through demonstration and operation as prescribed by law.
- xxxviii. To do all such other things as may be conducive or incidental for the attainment of the aforesaid objects or any of them.

#### **4. NON PROFIT CHARITABLE TRUST**

All the incomes, earnings, movable/immovable properties of the Trust shall be solely utilized and applied towards the promotion of its aims and objects only, as set forth in this Trust Deed and no profit or part thereof shall be paid or transferred, directly or indirectly by way of dividends, bonus, profit or in any manner, whatsoever, to the present or past Trustees of the Trust or to any person claiming through any one or more of the present or the past Trustees. No Trustee of the Trust shall have any personal claim on any movable or immovable properties of the Trust or make any profits, whatsoever, by virtue of his Trusteeship.

However, nothing contained herein shall prevent the payment in good faith of honorariums, remuneration and reimbursement of expenses in connection with any activity/business of the Trust or payment of interest on money borrowed from any Trustee of the Trust or any other person or persons.

Investment of the Trust money will be according to section 11(5) of the Income Tax Act, 1961. All the assets of the Trust shall vest in the Trust.

#### **5. TRUST FORMATION & AFFILIATION**

##### **A. Trust Board of the Trust**

The Trust Board will have Legislative and Executive Powers of the Trust.


##### **i. CONSTITUTION:**

As per Amended Supplementary Trust Deed,

The Trust Board shall nominate other trustees from the Society which are persons of distinction, special skill & experience without any distinction of cast, colour and creed and agreeing to the objectives of the Foundation (Trust) as members of the Trust Board. Total number of Trustees will not be more than 15. Any key person working with any other similar organisation can be nominated as member of Trust Board.

In the absence of Settler at the time of registration of any supplementary Trust Deed, any of the Trustee duly authorised by Chairman of the Trust Board is empowered to sign and get the supplementary Trust Deed registered with the office of Sub-Registrar.

Any person irrespective of religion caste, creed, sex, colour and agreeing to the objectives of the Trust is eligible for the Trusteeship of the Trust.

Bharat Lok Shiksha Parishad, Trust can get itself affiliated with any other similar organisation, having similar aim & objects and working in India, to seek guidelines for further improvement of its working in rural & tribal areas of the country for the betterment of brethren & sisters residing in such areas.

**B. OFFICE BEARERS OF TRUST BOARD:**

This Trust Board will nominate one Trustee from amongst the existing Trustees each as CHAIRMAN, VICE CHAIRMAN, SECRETARY & CONVENER of the Trust Board. The other 11 Trustees will be members of the Trust Board.

**C. TENURE OF CHAIRMAN, VICE CHAIRMAN, SECRETARY, CONVENER & MEMBERS OF THE TRUST BOARD:**

Tenure of the Chairman, Vice Chairman, Secretary & Convener of the Trust Board shall be three years from the date of nomination by the Trust Board in the same capacity.

One third of the remaining Trustees will retire every year on the basis of their date of Nomination. The retiring Trustees will be eligible for re-nomination as Trustee.

Any casual vacancy in the Trust Board shall be filled in by the Trust Board as per recommendation of Nomination Committee.

Any Trustee can be removed by the majority decision of the Trust Board taken in a meeting where 2/3rd members of existing strength are present.


**D. NOMINATION COMMITTEE:**

Any vacancy arising in the Trust Board shall be filled considering the name(s) recommended by the nomination committee after due deliberations in its duly convened meeting. The Trust Board will every year approve constitution of the Nomination Committee, its Chairperson & the nominations presented by it. The Nomination committee for recommending the name(s) to fill the vacancy in Trust Board shall consist of three members as below;

- i. One from the Trust Board
- ii. One from the Managing Committee
- iii. One from the advisory Board

Names of all such suitable persons to fill the vacancy in the Trust Board shall be presented by the Chairman of Nomination Committee before the end of the every financial year.

## **E. KEY FUNCTIONARIES OF TRUST BOARD:**

The following key office bearers shall work as key functionaries authorised to represent Trust Board as lawful signatories before any Govt. departments/authorities like Income Tax department, Ministry of Home Affairs for FCRA related matters, Ministry of Corporate affairs for CSR purposes etc. etc. in relation to any activity as required for carrying out day to day execution & operation of the Trust Board.

- i. Trustee Prabhari
- ii. President Managing Committee
- iii. Working President Managing Committee
- iv. General Secretary Managing Committee
- v. Treasurer Managing Committee

### **i. MEETING OF THE TRUST**

- (a) The meetings of the Trust Board shall be convened by the Convener of Trust Board by giving minimum 1 weeks' notice in writing. The Chairman of Trust Board shall have the power to call the meeting of the Trust Board at any time as and when he considers it necessary. In case any Trustee considers any urgency to have a Trust Board meeting, he/she can approach Chairman for the same.
- (b) The meeting of the Trust Board shall be held at least once in every 3 months. However, due to any reason if any meeting is not held once in every 3 months, at least 4 meetings in a year are must. Meeting of the Trust Board can also be held through audio/video conference mode.
- (c) Minutes of the meeting shall be read out at the next meeting of the Trust Board and any objection made by any Trustee who was present in the meeting concerned shall be recorded in the minutes. Thereafter, such minutes will be final and conclusive and the implementation of the decision as shown in the minutes will be carried out accordingly.

A resolution can be deemed to have been passed by circulation among the members of the Trust, if assented to by majority of the members.


### **ii. QUORUM OF TRUST BOARD MEETING:**

5 or 1/3<sup>rd</sup> of the total strength of the Trust, whichever is less, present in a meeting shall form the quorum. If within half an hour from the time fixed for the meeting, the quorum is not present, the meeting shall stand adjourned for the same day after half an hour at the same place to discuss the same agenda and for such adjourned meeting, no quorum is required. However, Any 2 out of 3 i.e. Chairman, Secretary or Convener are necessary to hold the meeting of Trust Board.

### **iii. SPECIAL INVITEES TO TRUST BOARD MEETING:**

Chairman, President, Working President, General Secretary & Treasurer of the Managing Committee shall be special invitee in the Trust Board meeting. Trust Board can invite any other person, which they consider necessary, as special invitee to the Trust Board Meeting.

## 6. Managing Committee of the Trust

### i. CONSTITUTION:

- a. The Trust Board will constitute the Managing Committee. The Managing Committee will be formed to run the various activities of the Trust. The maximum number of members of Managing Committee shall not be more than 51 (Fifty-One).
- b. The Trust Board will nominate the Chairman, President, Working President, General Secretary and Treasurer of the Managing Committee.
- c. The Office Bearers and Executive Members of Managing Committee will be nominated by the Trust Board in consultation with Chairman, President, Working President, General Secretary and Treasurer of the Managing Committee.
- d. The Management of the Trust and all movable and immovable properties of the Trust shall vest in the name of Trust and Managing Committee will be responsible for its efficient use and maintenance for the benefit of the Trust.
- e. All documents, deeds, acts and things to be executed or done by or in favour of the Trust shall be executed by or in the name of the Chairman of Trust Board.

**iii. TENURE OF MANAGING COMMITTEE:**

The tenure of the Managing Committee will be 3 Financial Years.

The new Managing Committee will be reconstituted by the Trust Board after 3<sup>rd</sup> Financial Year.

The Trust Board may re-nominate the office bearers of the Managing Committee any number of times.

**iv. MEETINGS OF THE MANAGING COMMITTEE**

- a. The meetings of the Managing Committee shall be convened by the General Secretary of the Managing Committee by giving minimum seven days' notice in writing. The President/Working President of the Managing Committee shall have the power to call the meeting of the Managing Committee at any time as and when he considers it necessary. In case, any member considers any urgency to have a Managing Committee meeting, he/she can approach the President / Working President/ General Secretary for the same.
- b. The Managing Committee meetings shall be held at least once in every month. However, due to any reason if any meeting is not held once in every month, at least 12 meetings in a year are must. Meeting of the Managing Committee can also be held through audio/video conference mode.


**v. QUORUM FOR THE MANAGING COMMITTEE MEETING:**

15 or 1/3<sup>rd</sup> of the total strength of the Managing Committee, whichever is less, present in a meeting shall form the quorum. If within half an hour from the time fixed for the meeting, the quorum is not present; the meeting shall stand adjourned for the same day after half an hour at the same place to discuss the same agenda. No quorum is necessary for an adjourned meeting. Presence of any 2 out of Chairman, President, Working President, General Secretary or Treasurer is necessary to hold the Managing Committee meeting.

**vi. PROCEEDINGS AND VOTING ETC. AT THE MEETINGS OF THE MANAGING COMMITTEE:**

- a. Questions arising at any meeting of the Managing Committee shall be settled by majority votes. Each members of the Managing Committee including President shall have one vote and decision at the meeting of the Managing Committee shall be taken by majority. In case of tie, the President shall have a


casting vote. In the interest of Trust, the Chairman of the Trust Board can exercise veto power to prevent any harmful decision or to implement important necessary decision.

- b. The Trust Board may nominate one member among themselves as PRABHARI for all meetings of Management Committee. The Chairman and other Trustees of the Trust Board may attend all the meeting of the Managing Committee. They will take part in the proceeding of the discussions but cannot take part at the time of voting, if any.
- c. Minutes of all the meetings shall be prepared by the General Secretary, who will sign and verify the correctness. The Chairman /President of the Managing Committee shall, after being read and confirmed by the members of the committee, sign the same as true and fair proceedings of the meeting.
- d. A resolution can be deemed to have been passed by circulation among the office bearers and members of the Managing Committee, if assented to by majority of the members.
- e. Minutes of the meeting shall be read out at the next meeting of the Managing Committee and any objection made by any member who was present in the meeting concerned shall be recorded in the minutes. Thereafter, such minutes will be final and conclusive and the implementation of the decision as shown in the minutes will be carried out accordingly.
- f. Minutes of the proceeding of the Trust Board and of the Managing Committee shall be kept by the President or the General Secretary in a safe custody.

**vii. RIGHTS AND OBLIGATIONS OF MANAGING COMMITTEE:**

1. The General direction, management and execution of all business connected with the affairs of the Trust shall vest in the Managing Committee.
2. Without prejudice to the generality of the powers conferred on the Managing Committee by Sub-Rule (i) above, the Managing Committee shall have the following powers:
  - a. To collect subscriptions/donations/corpus funds and all other sums of money due in connection with the affairs of the Trust.
  - b. Delegate, subject to such conditions as they think fit, any of their powers to members of the Committees formed under the



Managing Committee and to make, vary and repeal Bye Laws or Rules for the regulation of the proceedings of such ad-hoc committees.

- c. enter into arrangements, upon such terms and subject to such conditions as the committee may deem desirable for working in collaboration with any Trust/Trusts organized for the better development of the Society, provided the objects for which such Trust is formed are not inconsistent with the objects of the Trust defined in this supplementary Trust Deed.
- d. To consult, appoint and nominate Chartered Accountants, advocates, solicitors or other counsel to advise them on all or any matters connected with the Trust and authorize all or any of them to represent the Trust in all duly constituted Courts of Law either Civil, Criminal or Revenue, Arbitration Courts whether as Plaintiffs, Defendants, Petitioners, Applicants, Appellants or Respondents etc., as the case may require.
- e. To apply generally the funds of Trust in furtherance of its objects.
- f. To borrow from Banks/ Financial Institutions/ other entities or persons including Trustees as may necessary from time to time any sum or sums of money for the purpose of the Trust on such terms and conditions as they may deem fit at their discretion with the consent of the Trust Board.
- g. To secure the repayment of the borrowing in such manner and upon such terms and conditions as they think fit of all sums borrowed for the Trust and in particular by creating, mortgage, charge or other security on the whole or any part of the property of the Trust.
- h. To receive gifts, donations, presents, etc. to purchase, sell, lease, hire, exchange or otherwise deal with the movable and immovable properties owned or held by the Trust.
- i. To nominate delegates/advisers etc. to represent the interest of Trust at conferences/seminars to which they are invited.
- j. To get the affiliation from Central Board of Secondary Education (CBSE) or other recognized Boards/ University of the Educational Institution (School/ College) to be run by the Trust and to do all such acts, deeds and things as may be required in connection thereto.
- k. To prepare and submit to the Trustees of the Trust a report on the working of the Trust together with the Audited Statement of

Accounts for the preceding year and may make suggestions or recommendations for their consideration.

1. All ordinary powers, including day to day affairs of the Trust, not specifically provided for in this constitution shall be exercised by the Managing Committee and in extra ordinary circumstances the Chairman /President / Working President may exercise such powers required for immediate action subject to ratification by the Managing Committee with the consent of the Trust Board.

## **7. OPENING OF BRANCHES (CHAPTERS)**

The Managing Committee of the Trust is empowered to establish and maintain branch offices (Chapters/Sub-Chapters) anywhere in India as it may deem fit and necessary for the attainment of the objects of the Trust.

## **8. YOUTH & MAHILA VIBHAG**

The Managing Committee at Head Office and at Branches (Chapters) may have Youth & Mahila Vibhags working under the guidance of Head Office and respective Branches (Chapters) committees.

## **9. BANK ACCOUNTS**

- i. The Managing Committee at Head Office may open Bank account or accounts with any nationalized or scheduled Bank or Banks, which shall be operated jointly by:

President or Working President or General Secretary

AND



The Managing Committee at its Branches (Chapters) and/or at other locations (except Head Office) may open Bank account or accounts with any nationalized or scheduled Bank or Banks, which shall be operated manually or electronically jointly by any 2 (two) out of the following five office bearers:

iv. The Managing Committee at its Sambhag/ Bhag/ Anchal/ Sanch and/or at other locations may open Bank account or accounts with any nationalized or scheduled Bank or Banks, which shall be operated jointly by any two out of the following five office bearers:

vii. Fixed deposits or other securities shall be in the name of the Trust and all documents and receipts, in respect thereof shall be signed by the President or General Secretary and Treasurer or by any other person authorized by the Managing committee.

## 10. ACCOUNTS & FINANCIAL YEAR


The property and income of the Trust shall be applied solely towards the promotion of the objects of the Trust as set forth in the Trust Deed. No portion thereof shall be paid or transferred directly or otherwise beneficial howsoever to the Trustee of the Trust provided that nothing herein shall prevent the payment in good faith of the remuneration of any officer or employee of the Trust or to any person for any services actually rendered.

- i. The Accounts of the Trust shall be kept regularly in accordance with the generally accepted accounting Principles and Policies.
- ii. All accounts shall be prepared for the financial year. The financial year of the Trust shall be from 1st April to 31st March.

## 11. AUDIT

- i. At the end of each financial year, the Managing Committee shall prepare an income & expenditure account and balance sheet, which duly audited by a qualified Chartered Accountant, appointed by the TRUST BOARD, will be produced by the Managing Committee for approval of the Trust Board.
- iii. Annual Report and the audit report shall be submitted to the Trust Board by the Managing Committee of the Trust well within 6 months of the closure of the accounting year for its approval.

## **12. CIRCUMSTANCES UNDER WHICH ONE WOULD CEASE TO BE A TRUSTEE**

Circumstances under which one would cease to be a Trustee of the Principal Trust Deed and shall be read as follows: -

- A. If he/she resigns him/herself.
- B. If he/she is declared insolvent by a court of Law.
- C. If he/she is convicted for moral turpitude by a Court of Law.
- D. If he/she is medically certified to be physically or mentally unfit.
- E. If he/she acts against the aims & objects of the Trust.
- F. If he/she abstains from five consecutive meetings of the Trust Board.

However, the person concerned would be served a show cause notice, which would mean giving him/her an opportunity to clarify his/her position. The removal decision would be taken by 2/3rd number of total Trustees.

## **13. INVESTMENT OF THE TRUST FUNDS**

Investment of the Trust Funds will be as per the provision of section 11(5) of the Income Tax Act. All the assets of the Trust shall vest in the Trust alone.

## **14. LEGAL PROCEEDINGS**

The Trust may sue or be sued in the name of the President or General Secretary of office bearer of Managing Committee as per the Provision of the Trust Act of NCT of Delhi.

All the Document of the Trust shall be kept in the Administrative Office of the Trust.

## **15. AMENDMENTS:**


While this Supplementary Amended Trust Deed shall be irrevocable, the Trustees of Trust Board may amend any of the clauses, at a duly convened meeting of the Trust Board with at least one-week notice, and by a resolution passed by at-least three-fourths majority of the Board of Trustees present and voting. The amendments to the Trust deed, can only be passed by a resolution of the Board of Trustees in an actual meeting and not by circulation.

If any alteration or amendment is necessary, the same shall be affected through supplementary deed/deeds and shall be read together with the main Trust deed.

## **16. DISSOLUTION OF THE TRUST**

In the event of the dissolution of the Trust if ever decided by the 2/3rd majority of present Trustees including Chairman/Vice Chairman, Secretary & Convener of the Trust Board, the liabilities of the Trust shall be made good and the assets of the Trust shall be transferred to any other Public Charitable Trust(s) or Society(ies) having similar aims & objects or National Defence/PM Care Fund of India, and in no case the assets shall be distributed among the trustees.
