To provide non-formal primary education through cost effective One Teacher school (O.T.S.) i.e. Ekal Vidyalaya.


Empower education by creating awareness about their rights, achieving their dues out of government projects with the help of Right to Information Act, enabling them to become self-reliant and live with self-respect.



Bharat Lok Shiksha Parishad inaugurated the campaign on the Dream wallet through digital media on 05 September 2020



### Notes Forming part of the Financial Statements as at March 31, 2021

#### 1. Significant Accounting Policies:

The Financial statements have been prepared in accordance with applicable accounting standards issued by the Institute of Chartered Accountants of India and generally accepted accounting Policies & Principles. A summary of accounting Policies applied are set below:

#### a). Convention:

The accounts are prepared under historical cost convention and on the basis of going concern concept.

#### b). Fixed Assets:

Fixed assets are stated at cost of acquisition or construction or book value less depreciation. Cost of acquisition is inclusive of Inward Freight, duties, taxes and all incidental expenses incurred up to putting the assets in use together with the cost of spares if supplied with the assets.

#### c). Depreciation:

Depreciation is charged at the WDV rates prescribed in the Income Tax Act, 1961.

#### d). Revenue Recognition:

Interest income is recognized on a time proportion basis taking into account the amount outstanding and applicable interest rate.

#### 2. Notes to the Accounts:

- a). Schedules 1 to 9 form an integral part of the balance Sheet, Income & Expenditure Account and Receipt & Payment Account.
- **b).** There is no contingent liability as on Balance Sheet date.




